I, the undersigned, agree to pay Grosse Pointe Driving School, Fifty-Three dollars (\$53.00) payable to the Grosse Pointe War Memorial, which includes a Five dollar (\$5.00) Historic Preservation Fee, by cash, check, money order, or credit card, for the prescribed Drive Education Course. **Grosse Pointe Driving School will provide a minimum of 6 hours of classroom instruction provided by a certified Michigan Driver Education Instructor.** Classroom instruction will not exceed 2 hours of instruction per day. Fees are to be paid in full prior to and/or on the first day of class to the Grosse Pointe War Memorial.

General Statement

In a classroom program such as this, a student will have to prepare for each lecture. If the student passes ALL the lecture requirements, passing the state test with a 70%, then the student may be permitted to receive his/her certificate. The student will be given up to 2 additional attempts to pass the test.

The only materials, which I must furnish, are pencils and notebook.
There are no makeup sessions for Driver Education Segment 2 classes.

Refund Policy – An \$8 processing fee will be charged if a student cancels prior to the second class. No refunds will be processed after the second class. Students will be charged a pro-rated amount for the first class. All refund requests must be in writing. If class is canceled due to insufficient enrollment, registrants will be notified by phone and a full refund will be issued.

I understand further that I will be expelled from the course if I do not conduct myself properly while in or about the class facilities and show due respect to class instructors as well as to my fellow classmates. If expelled, the course refund formula described in the preceding paragraph would apply.
