I, the undersigned, agree to pay Grosse Pointe Driving School, Two Hundred Eighty-Nine dollars and 50 cents (\$289.50), payable to the Grosse Pointe War Memorial which includes a Seven dollar (7.00) Historic Preservation Fee, by cash, check, money order, or credit card, for the prescribed Drive Education Course. Fees are to be paid in full prior to and/or on the first day of class to the Grosse Pointe War Memorial.

General Statement

In a classroom program such as this, a student will have to prepare for each lecture. If the student passes ALL the lecture requirements, class test with an 80%, state test with at least a 70%. Students must pass with satisfactory or higher, ALL BTW Performance Objectives, per the Driver Education and Instructor Act (DEPIA) at the instructor's professional discretion. The student will be given up to 2 additional attempts to pass the test.

Please bring with you to the first day of class: **COMPLETED CONTRACT, PEN, PENCIL and NOTEBOOK**

Make-up days for classroom instruction and Behind-the-Wheel instruction will be made with the instructor.

"The student must be at least 14 years and 8 months of age by the first day of a Segment 1 course. Verification by birth certificate is required.

Refund Policy-An \$8 processing fee will be charged if a student cancels prior to the second class. No refunds will be processed after the second class. Students will be charged a pro-rated amount for the first class. All refund requests must be in writing. If class is canceled due to insufficient enrollment, registrants will be notified by phone and a full refund will be issued.

I understand further that I will be expelled from the course if I do not conduct myself properly while in or about the class facilities and show due respect to class instructors as well as to my fellow classmates. If expelled, the course refund formula described in the preceding paragraph would apply.

Grosse Pointe Driving School, Inc. will provide a minimum of 24 hours of classroom instruction, 6 hours of behind-the-wheel (BTW) instruction and 4 hours of observation time provided by a certified Michigan Driver Education Instructor. Grosse Pointe driving School, Inc. will conduct the behind-the-wheel instruction in a dual controlled automobile, fully insured, covering each student enrolled in the program. Classroom instruction must be a minimum of 3 weeks in length. BTW instruction shall not begin until the student has received a minimum of 4 hours of classroom instruction. BTW instruction must be completed no later than 3 weeks after the classroom instruction has been completed.

I further understand that there will be a twenty dollar (\$20.00) fee for each one (1) hour driving appointment missed and that these appointments may be canceled 24 hours prior to drive. Student are asked to be at their practice driving appointments 5 minutes prior to when the session begins. **A \$15 check is payable by the last day of class to Mark Avolio for \$5 book rental fee and \$10 gas surcharge.** Each student will also be given a binder that must be returned. If lost or not returned a \$25 fee will be charged. There will be a \$10 replacement fee for lost certificates.
